Mark suggested that in order to make the budget process more educational and informative for the board, everyone should be included in email discussion and questions regarding the budget and financial documents.

5. Capital Campaign

Make It MOCO Proposal was presented in draft form - The proposal is focused on

how to pay loans that are due on July 1, 2021 and increase cash flow. This campaign would be an attempt at solving our long-term debt. Several suggestions were discussed by the board concerning what a campaign of this nature should include.

Using the line of credit is may be a possibility as a last resort to pay Year 4 loans. However all this would accomplish is to postpone things until Year 5 loans are due.

The board is well aware of the seriousness of the financial situation. One suggestion which will be discussed in more detail is the notion of hiring outside marketing experts to help with the fundraising campaign. The board also was in agreement that the GM needs to be an integral part of this effort.

Elly would like to see a strategic planner enlisted to look at next two to three years. A campaign would help pay off short-term debt, but we need a bigger picture look into the future.

Several board members feel the board should make a motion to pay off the 4 year loans even though a way to accomplish this has not yet been agreed upon. If the loans are not paid off there is a likelihood that the board will be in default.

It was mentioned that if someone donates to the MOCO, it goes into CFNEand held in escrow.

The board agreed that the store is in a positive place and when a solid plan is developed to raise more money

MOCO will be successful.

Larry, Kelly and Rachel need more time to look over the proposal and consider voting to pay off 4 year loans. Elaine makes a motion to accept an email vote on Monday about paying down year 4 loans. Kelley seconds it. All in favor.

Jack – we need to update the board bios and pictures on the website. Rachel will reach out to the board and MJ has a template for staff.
