# 1. Don called the meeting to order at 5:03 pm

## 3. New Board

Don shared Annual Meeting Election <u>Results</u> and welcomed newly-elected board members - Megan Davin, Stephanie Davison, Jessica Seddon, Dave Wallack - and re-elected board members - Dave Carter and Susan Titterton.

Chair runs the Board meetings, prepares the agenda. The Secretary takes the minutes, makes sure they are filed and posted. Stephanie noted she doesn't have the time to jump into any of these bigger roles. Jessica said she might be willing to be a Co-Chair if a current board member could share the job. Susan might be willing to continue as Vice Chair. Agreement was made to discuss this further and decide at the Board meeting on Nov. 16.
